What is the product?

Туре

The product is the Class A investment shares denominated in USD of WEALTH GLOBAL BOND USD OPPORTUNITIES, an investment compartment (the "Investment Compartment") of WEALTH ALTERNATIVE SERVICES AIF V.C.I.C. PLC (the Company"). The Company operates as an Alternative Investment Fund (the "AIF") with four (4) investment compartments in the form of a variable capital investment company in accordance with the Alternative Investment Funds Law 124(I)/2018, as amended from time to time (the "AIF Law"). The Company is externally-managed by WEALTH FUND SERVICES LIMITED (the "External Manager"), a private company limited by shares which is authorized by the Cyprus Securities and Exchange Commission to operate as a UCITS Management Company and as an Alternative Investment Fund Manager with license number MC UCITS 6/78/2012 in accordance with the Open—Ended Undertakings for Collective Investment (UCI) Law of 2012 and the Alternative Investment Fund Managers Law of 2013, both as amended from time to time. The Company issues investment shares, which are allocated to the Investment Compartment, and carry non-voting rights, in accordance with the Company's prospectus and relevant supplement. Neither the Company nor the Investment Compartment are listed in any regulated exchange market or multilateral facility. Participating Shares in the Company may be purchased or redeemed on a weekly basis. The Depositary of the Company is Eurobank (Cyprus) Ltd. The Participating Shares in the Fund carry the right to distributions to be made out of the profits of the Company to the Investors.

Duration

This investment has no maturity date. There are circumstances under which the Company may be entitled to terminate the investment in the Investment Compartment unilaterally. Circumstances under which the termination of the investment can occur include, inter alia, the investment being held by or for the benefit (directly or indirectly) of an ineligible investor or being acquired in breach of any applicable laws or the termination of the investment would eliminate or reduce the exposure of the Company to any tax and/or regulatory adverse consequences.

Objectives and Investment Policy

The Investment Compartment's objective is to provide investors with ideal returns. from a diversified portfolio consisting mainly of fixed income assets. The Investment Compartment's investment strategy is to invest predominantly in debt securities such as corporate bonds, government bonds, promissory notes, debentures and other structured products. Investments in listed equities may also be pursued. The aim of the Investment Compartment is to invest in global developed markets as well as in emerging markets that can present various opportunities even at difficult economic conditions. To achieve this approach, the External Manager shall adopt a systematic, long-only investment methodology involving extensive quantitative screening on the basis of a number of key parameters and proprietary valuation models (as outlined in the Company's prospectus and Investment Compartment's supplement). The Investment Compartment may pursue secondary investments in cash and cash equivalent instruments for diversification purposes only. The Investment Compartment is subject to investment restrictions and limits as further elaborated in section "INVESTMENT RESTRICTIONS" of the Company's prospectus. The Company will not employ any leverage on behalf of the Investment Compartment. The return for the Investment Compartment is determined by using the following appropriate proxies: 70% USD Liquid High Yield Index (IBOXHY), 20% USD Liquid Investment Grade Index (IBOXIG) and 10% the S&P 500 Index.

Investor profile

Apart from professional investors (as defined in the Second Appendix of the Investment Services and Activities and Regulated Markets Law 87(I)/2017 as amended from time to time), this product is also suitable for retail investors who (i) have medium to high risk appetite; (ii) qualify as well-informed investors (as defined in the AIF Law); (iii) understand the risks associated with the Investment Compartment; and (iv) are seeking returns over the medium to long term horizon. The product may not be appropriate for investors who plan to withdraw their money within two (2) to three (3) years from their investment. The investor's objective for this investment should be aligned with the objective of the product as outlined above and in the Investment Compartment's supplement.

What are the risks and what could I get in return?



Lower Risk



The risk indicator assumes you keep the Product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The SRI is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7 which is a 'medium-low' risk category. This rates the potential losses from future performance at a medium- low level and poor market conditions are unlikely to impact the capacity to pay you. This product does not include any protection from future market performance so you could lose some or all of your investment.

Warning: Be aware of currency risk. You will receive payments in USD which may be different from the currency of your investment, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The following are additional risks materially relevant and not covered by the risk and reward category:

Country Risk/Sector Risk/Issuer Risk/Currency Risk

The risk of investing or having exposure in a specific country, sector, issuer and currency which depends on political, legal, economic and social risks of that country, the prospects of the specific industry sector within the country and the business prospects and financial position of any particular issuer within the sector. Moreover, any pertinent investment may carry different currency risk depending on the jurisdiction of issuance. For Single Currency Products (eg USD) it is emphasized that currency risk is among the top risks.

Market Risk

The risk of loss resulting from fluctuation in the market value of positions in the portfolio attributable to changes in market variables, such as interest rates, foreign exchange rates, equity and commodity prices or an issuer's creditworthiness.

Operational and Safekeeping Risks

The risk of loss resulting from inadequate internal processes and failures in relation to people and systems of the External Manager or from external events, and includes legal and documentation risk and risk resulting from the trading, settlement, safekeeping and valuation procedures.

Impact of Financial Techniques

The risk of loss resulting from utilizing specific derivatives on financial instruments which are intensified by the leverage structure of these products (e.g. fluctuation of the underlying asset, counterparty risk in the case of overthe-counter transactions, liquidity, etc.).

Liquidity Risk

The risk that a position in the portfolio cannot be sold, liquidated or closed at limited cost in an adequately short time frame and that the ability to redeem shares at the request of an investor is therefore compromised.

Performance Scenarios

The unfavourable, moderate, and favourable scenarios shown below are illustrations using the worst, average, and best performance of the Product. The stress scenario shows what you might get back in extreme market circumstances. What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

This table shows the money you could get back over the next 1 or 3 years, under different scenarios, assuming that you inv est 10.000 USD. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other pro ducts. The scenarios presented are an estimate of future performance and are not an exact indicator. What you get will vary depending on how the m arket performs and how long you keep the product. The figures shown include all the costs of the product itself but may not include all the costs that you pay to your advisor or distributor. This means it is difficult to estimate how much you would get back if you are willing to cash in before the recommended holding period (3 years). You will either be unable to cash in early or you will have to pay high costs or make a large loss if you do so. The figures do not take into account your personal tax situation, which may also affect how much you get back.

The unfavourable scenario occurred for an investment between October 2021 - October 2022 (if you exit after 1 year) and between October 2019 - October 2022 (if you exit after 3 years).

The moderate scenario occurred or an investment between June 2019 - June 2020 (if you exit after 1 year) and between January 2019 - January 2022 (if you exit after 3 years).

The favourable scenario occurred for an investment between March 2014 - March 2015 (if you exit after 1 year) and between January 2014 - January 2017 (if you exit after 3 years).

What happens if the compartment is unable to pay out?

In the event of default of the Compartment, there will be a direct impact on investors. Deposits by collective investment schemes are excluded from the Cyprus Deposit Guarantee and Resolution of Credit and Other Institutions Scheme. The investors in the Compartment are protected by any investor compensation or quarantee scheme.

What are the costs?

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you wit h information about these costs and show you the impact that all costs will have on your investment over time.

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account, one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for one holding period. The figures assume you invest 10.000 USD. The figures are estimates and may change in the future.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different investment periods. In case you decide to exit before the product ends, exit costs may apply in addition to the amounts shown here.

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding period we have assumed the Product performs as shown in the moderate scenario.
